ADDITIONAL CONDITIONS:

1. Rebate form and documentation must be received within 6 months of completed project.
2. Available to OPALCO residential members. Single family residences, manufactured homes and multi-unit buildings with four units or less are eligible. Residential structures must be in a habitable condition with a primary electric heat source. All structures must be on an OPALCO residential electric rate and have an active residential account.
3. Homeowners are responsible for complying with all applicable codes and regulations.
4. Members doing the work themselves (without using a licensed contractor) may be subject to inspection by an OPALCO Energy Advisor at no charge prior to payment of incentives.
5. Incentives less than \$100 are applied as a credit to the member's account; greater than \$100 are paid directly to the member/homeowner by check.
6. OPALCO reserves the right to inspect energy efficiency measures prior to payment and will coordinate inspection as applicable.
7. Please allow 6-8 weeks for processing and payment of incentives.



WINDOW ELIGIBILITY:

- Replacement windows must have a NFRC U-Factor of 0.30 or lower
- Replacement French or sliding glass doors must have U-Factor of 0.35 or lower
- New windows cannot be larger than existing; garden windows not eligible; no new or added windows
- Square footage, the U-Factor ratings and cost must be itemized on the invoice—in addition to being listed on this rebate form
- Remove window stickers and include stickers (or copies) with this rebate form
- Contractor must follow BPA weatherizations specifications (available at www.opalco.com—or call 376-3571)
