ADDITIONAL CONDITIONS:

1. Available to OPALCO residential members. Single family residences and manufactured homes are eligible. Residential structures must be in a habitable condition with a primary electric heat source. All structures must be on an OPALCO residential electric rate and have an active residential account.
2. Homeowners are responsible for complying with all applicable codes and regulations.
3. Incentives less than \$100 are applied as a credit to the member's account; greater than \$100 are paid directly to the member/homeowner by check.
4. OPALCO reserves the right to inspect energy efficiency measures prior to payment and will coordinate inspection as applicable.
5. Please allow 6-8 weeks for processing and payment of incentives.



HEAT PUMP ELIGIBILITY

Available for new or existing single-family and existing manufactured homes. The electric heat pump must be the primary system used to meet the heating needs of the house to qualify. Homes with heated floor area greater than 4,500 sq. ft. may claim up to two qualified heat pump measures. PTCS work must be installed by a PTCS certified technician. There are two types of qualifying heat pump measures:

1. **UPGRADE** Replacing and existing heat pump or adding heat pump to non-electric heating system (HSPF 9.0/SEER 14)
2. **CONVERSION** Converting electric forced-air furnace to high-efficiency heat pump (HSPF 9.0/SEER 14)
3. **MEETS MINIMUM FEDERAL STANDARD** (HSPF 7.7/SEER 13)
