Requirements and Specifications

- Replacement windows must have a NFRC U-Factor of 0.30 or lower or 0.22 or lower
- Replacement patio doors must have a NFRC U-Factor of 0.35 or lower or 0.30 or lower
- Windows must be installed according to the BPA Residential Weatherization Specifications

Documentation Requirements

- Completed rebate application
- Equipment or contractor invoice showing:
 - o Order or purchase date
 - o Cost
- NFRC stickers or other verification of U-Factor
- Documentation of number and square foot of windows or patio doors

Payment

- The rebate for upgraded windows with the U-Factor of 0.30 or lower and patio doors with the U-Factor of 0.35 of lower is \$6 per square foot
- The rebate for upgraded windows with the U-Factor of 0.22 or lower and patio doors with the U-Factor of 0.30 of lower is \$8 per square foot
